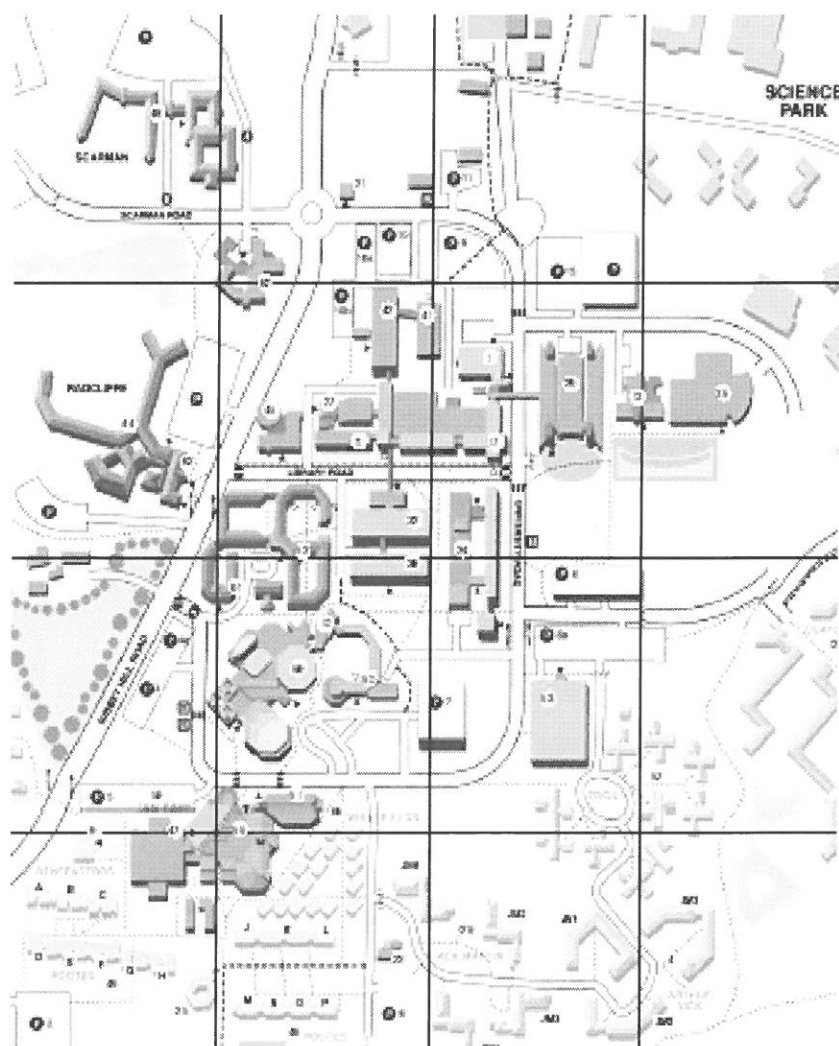


Campus Map
